Established in 1928 Highbrook is the longest continuously operating camp for people with blindness or visual impairments. Accredited by the American Camp Association (57 camper experiences hosted). Recreation services include activities such as social clubs and book discussion groups for persons who are blind or visually impaired (1,339 recreation virtual and in-person program experiences).

CSC provides assistive technology and other services, including retail sales of aids such as magnifiers, "talking" items, and large print accessories. CSC's retail store offers useful products to help people with vision loss live more safely and accomplish daily tasks with greater ease. Open to the public and online. (Open year-round, serving >1,000 clients). Braille and large print materials are produced and provided to individuals to read information needed for school, business, and leisure, staffed in part by volunteers trained by the Library of Congress. A radio reading service is provided through Cleveland Sight Center's network ("CSCN") broadcasting as a subcarrier of SCPN 90.3, on WVIZ-TV channel 25.9, and on ClevelandSightCenter.org. CSC also provides customized audio for client needs at home, school, and work.
