What's Happening at CSC:

- -The Coordinator of the Cleveland Division of Police Crisis Intervention Team contacted CSC this week regarding using proper language relative to someone who is blind or visually impaired as the department is reviewing and updating their policies and documents.
- -Outreach met with staff at Middleburg Heights Community Center to provide CSC collateral for an upcoming event they're hosting and to give an overview of CSC's programs and services. In addition, Outreach presented the "Blindness Basics" training for 1st and 2nd year students enrolled in the Occupational Therapy Assistant program at Bryant & Stratton College. The week concludes as Outreach visits the Westlake Community Center for an agency overview presentation, followed by a meeting at the Rocky River branch of the Cuyahoga County Public Library with a librarian who is planning a Braille program for 2nd and 3rd grade level library patrons scheduled for early 2022.
- -Students in Bright Futures Preschool will be participating in the 2021 Great Lakes Apple Crunch! On Thursday, October 14th early care centers, schools, hospitals, colleges and other organizations will be crunching into a local apple at noon local time for the 8th Annual Great Lakes Great Apple Crunch! Reinstating Siri actions to check call history and voicemail will take a bit more time, and we will bring back this functionality in an upcoming iOS software update."
