Established in 1928 Highbrook is the longest continuously operating camp for people with blindness or visual impairments. Accredited by the American Camp Association (196 camper experiences). Recreation services include activities such as sailing, golf, tandem biking, crafts, line dancing, social clubs, book discussion groups, and audio-described theater for persons who are blind or visually impaired (406 recreation experiences).

CSC provides assistive technology and other services, including retail sales of aids such as magnifiers, "talking" items, and large print accessories. The "Eye-Dea Shop" retail store offers useful products to help people with vision loss live more safely and accomplish daily tasks with greater ease. Open to the public and online. (Open year-round, serving 2,600 clients). Braille and large print materials are produced and provided to individuals to read information needed for school, business, and leisure, staffed in part by volunteers trained by the Library of Congress. A radio reading service is provided through Cleveland Sight Center's Network ("CSCN") broadcasting as a subcarrier of SCPN 90.3, on WVIZ-TV Channel 25.9, and on [ClevelandSightCenter.org](http://ClevelandSightCenter.org). CSC also provides customized audio for client needs at home, school, and work.
