CSC Provides Testimony in Support of House Bill 586 in Columbus This Week:

-Kevin Krencisz visited the Ohio Statehouse in Columbus earlier this week to provide proponent testimony to the Ohio House State and Local Government Committee in support of House Bill 586. The testimony was crafted with continued efforts by Jassen Tawil, Larry Benders and our lobbyists at Capitol Partners. House Bill 586 is proposed to amend sections of the Ohio Revised Code to require any state agency seeking to purchase supplies or services to comply with an applicable first or second procurement program. The bill moves to prohibit any governmental ordering office from combining multiple parts of a larger related project to avoid using the procurement list maintained by community rehabilitation programs (CRP). The Call Center at CSC has been a partner of the CRP for many years which has resulted in opportunities to work with many Ohio agencies. Cleveland Sight Center also had support for the testimony from the Cincinnati Association for the Blind & Visually Impaired, the Ohio Association of Goodwill Industries and Vocational Guidance Services.

What's Happening at CSC:


