CSC Receives Gift from the Theodore Zuck Trust:

• CSC was named a beneficiary of the Theodore Zuck Trust and recently received a gift of \$30,000. Theodore T. ("Ted") Zuck was an endocrinologist who lived in the Cleveland area who passed away in 1983, upon which a trust was established for the benefit of his wife, who passed away in September 2016. The principal of the trust was to be distributed "to various charitable, tax-exempt organizations that are primarily engaging in furnishing services to blind people in the United States of America." The executor of the trust selected CSC among a very large number of charities in the country who assist those who are blind or have low vision after researching CSC and deeming it both eligible and worthy of support based on Charity Navigator and other sources.

CSC Receives Grant from GPD Group Employees Foundation:

• CSC received a \$5,000 grant from The GPD Group Employees' Foundation, a consortium of employees from different companies that formed in 2014 to have a vehicle for giving back. The group's vision is "to make a difference in the lives of children" and their mission is "to encourage the enrichment of the public education experience for K-12 students and to support children with medical and special needs." Representatives of the foundation visited CSC on Friday, June 23rd for lunch and a tour of the agency with Karen Bain Hiller and Sylvia Snyder. The grant dollars will support CSC's Early Intervention program.

It's Camp Season at Highbrook Lodge:

- It's been a busy couple weeks at Highbrook Lodge! Since Friday, June 16th, staff members have been hard at work in staff training for over 14 hours a day. This year's camp staff consists of 21 seasonal staff members, including 10 returning staff members. Counselors received training with CSC employees Lisa Cellura, Mary Jo Chisnell and Scott Williams-Riseng, as well as the members of the Highbrook Leadership Team. Training has extensively covered healthy eating, personal care, emergency preparedness and program planning. Every counselor holds a certification in First Aid, CPR, Blood-Borne Pathogens, AED and Epi-pen administration. Counselors are also joined by a Registered Nurse who lives on the property and manages all camper medication. In between training sessions, the staff members have been having fun with a camp-wide game of Human Clue and anticipation of the first group of campers, who arrived this week. This week, the crew welcomed 28 campers to the Celebration session for adults with multiple disabilities. Campers have been able to participate in archery, swimming, canoeing, outdoor camping, and much more, thanks to the wonderful staff!

Wellness Squad Corner:

• The Importance of Keeping an Updated First Aid Kit Having a first aid kit nearby is extremely important. At some point in your career or home life, it is likely that you will access it. If a wellstocked first aid kit is available, it can minimize the health risks of the injured and allow treatment to begin promptly. First aid kits vary depending on their purpose. Some are used for one individual while others are prepared to service larger groups such as a workplace. It is important to remember who is going to be using the kits and what the personal or organizational needs may be when you are preparing them.

First aid kits can be used to treat variety of injuries or illnesses including cuts, burns, sprains and strains. Bigger kits can include medication such as over the counter anti-inflammatory or antibiotic ointments to treat smaller injuries or act as a first response. Twice a year, check your first aid kit for expiration dates to ensure safety. If a

drug is outdated it will not be as effective and can cause negative side effects.

First aid kits can be made or bought already prepped. If you prep your own kit, be sure to include all necessary materials. Once a first aid kit is prepped it is important to train employees and family members on how to use the material. Basic first aid can save lives. Keep a list of emergency numbers in the kit. For personal kits, keep a list of medications you are on for emergency personnel if they are needed.

Items of Note:

- CSC will be closed in observance of Independence Day on Tuesday, July 4th. The agency will be open on Monday, July 3rd.
- Register for the 2017 Technology Fair! This year's event will be held at CSC on Thursday, July 27th and Friday, July 28th and will showcase new, emerging and established technologies as well as CSC's programs and services. Thursday's session is from 9:00 a.m. 4:00 p.m. and is open to the general public, senior centers, caregivers and technology-seekers. - CSC was visited on Tuesday, June 27th for an infrared scan of the electrical supply and distribution system for the agency, which is done as part of a good predictive/preventative maintenance program. There were no findings during the inspection.

 Beginning Wednesday, July 5, crews working on Section 1 of the Opportunity Corridor Project implemented a new traffic pattern at the intersection of Chester Avenue and East 105th Street. Work at the intersection is expected to take approximately six weeks. Chester Avenue has been reduced to one lane in each direction at East 105th Street to construct the southeast and southwest corners of the East 105th Street and Chester Avenue intersection.

The following turning movements have been restricted:

- Eastbound Chester Avenue motorists will not be able to turn right onto southbound East 105th Street.
- Westbound Chester Avenue motorists will not be able to turn left onto southbound East 105th Street.
- Northbound East 105th Street motorists will not be able to turn right or left onto Chester Avenue.
- While these turning movements are restricted, motorists are encouraged to use East 100th Street as an alternate route.

Did You Know?

- July 4th, also known as Independence Day, is the federal holiday marking the Colonies' adoption of the Declaration of Independence on July 4, 1776, which declared independence from the Great Britain and its king. This holiday goes hand in hand with fireworks, parades and grilling. Did you know:
 - The Fourth of July was not declared a national holiday until 1941.
 - The stars on the original American flag were in a circle so all the Colonies would appear equal.
 - The number of Americans who will spend the holiday at other people's homes is approximately 41 million.
 - The first official Fourth of July party was held at the White House in 1801.
 - o Approximately 150 million hot dogs are consumed on this day.
 - o The town of Patriot, IN has a population of 202 people.
