Creating and Strengthening Partnerships:

- Representatives from the Olmsted Center for Sight in Buffalo, New York visited CSC on Wednesday, July 15th in response to an invitation by Jassen Tawil. Jeffrey Hirschfelt, Kelly Dodd, and Imtiaz Khan spoke of the vision rehabilitation services offered by the Olmsted Center, their call center that operates the region's 2-1-1 services for the United Way, and their nationally-known and highly successful employment training program for the hospitality industry. The group met with CSC's team of Larry Benders, Dr. Anthony Easley, Sylvia Snyder, Jassen Tawil, Greg McGrath and Joel Zureick on programs and services and expressed a desire to explore opportunities for collaboration and information sharing with CSC. Mr. Khan, Olmsted Center's Trainer and Workplace Support Manager, had the opportunity to meet with his former colleague, Jennifer Dean, who later came to CSC to be Assistive Technology Instructor and Braille Services Coordinator.

As a result of the meeting, Nancy Sidell, Equal Access Services Coordinator visited CSC on Thursday, July 23rd to provide an in-service to CSC's Supported Employment team on how to better utilize OMJ services. - Rights of Persons Served. CARF-accredited organizations protect and promote the rights of all persons served. This commitment guides the delivery of services and supports and ongoing interactions with the persons served. How do all persons served learn about and understand their rights? How does the person served gain access to their records? How do we protect and advocate for the rights and assets of persons served? What is our process for resolution of a consumer complaint or grievance? How do we as an organization deal with allegations of infringements of a person's rights? CARF surveyors will wish to understand how the organization identifies protocols related to formal complaints, including grievances and appeals, or it may include these in a common policy and procedure covering complaints, grievances and appeals.

In this framework, CARF's existing business practice standards were restructured to provide a logical, action-oriented approach to ensure that organizational purpose, planning, and activity result in the desired outcomes.

Many of the program-specific standards for Medical Rehabilitation were significantly revised and new standards were added to expand accreditation opportunities across the continuum of services and specialty programs.
